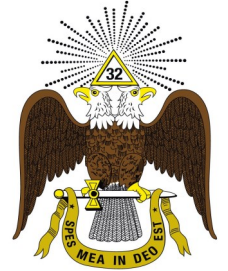

## *Master of Kadosh of the Consistory*

John Stewart Dahik, Master of Kadosh of the Consistory

Hello! I am Brother John Dahik, and I am the Master of Kadosh of the Alexandria Consistory. A little bit of background about me is as follows: I was born in Arlington Heights, Illinois on March 7, 1990. I moved with my family to Seaford, Virginia in the Spring of 1995, and would call Seaford home until 2006 when I moved to Alexandria, and I continue to call Alexandria home today. I graduated from West Potomac High School in June 2008, and immediately began my studies at Northern Virginia Community College with a concentration in General Studies. I graduated in 2011, and transferred to George Mason University in the fall of 2011, and graduated in 2013 with a Bachelor of Science in Criminology. After college, I worked for numerous private security companies providing access control, and still continue to do that today for the DoD.



My Masonic journey began August 18, 2010 when I was initiated an Entered Apprentice in Mount Vernon Lodge No. 219, passed to the degree of FellowCraft on October 27, 2010, and finally raised to the sublime degree of Master Mason on February 16, 2011. My overall goal this year as the Master of Kadosh is not only to ensure my officers participate in the meetings, but more importantly, to mentor new Scottish Rite Masons and encourage participation in the Spring and Fall Reunions... as well as in other fun activities. Speaking of events upcoming, we have the Scottish Rite/Kena Shrine joint picnic on July 27th at Kena Shriners in Manassas. Start time is 11AM and ends at 2PM. RSVP on Kena.org. Admission is free! 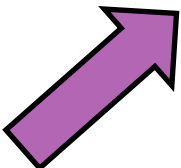

## *Ladies Night Dinner and Program*



Our Ladies joined us prior to our 10 May Stated Meeting to enjoy a delightful dinner prepared by our Ladies of the Oriental Shrine, Al Manara Court No. 50, and two special programs. The first program was presented by our Brother Fred Baerenz, 32°, who, as a Past DeMolay International Master Councilor, presented a letter-perfect DeMolay Flower Talk for the Ladies. Each of the Ladies' escorts then presented them with a red rose to commemorate the evening and the Brothers then excused themselves for a brief Stated Meeting while the Ladies were presented with a fascinating program by Brother Daniel Froggett, 32°.

As we were near the 80th Anniversary of D-Day, as well as the 100th Anniversary of the birth of the American Foreign Service, Bro. Froggett regaled the Ladies with the history of Arlington Hall, located near Arlington Centennial-Glebe Lodge. Originally surveyed by Bro. George Washington in 1775, the property was purchased in 1942 by the US Signal Intelligence Service, where the predominantly female codebreakers were instrumental in the deciphering and analysis of enemy codes during WW2. By the end of the war, the staff had grown to some 8,000 people, and eventually became the original site of the National Security Agency before it relocated to its present Ft Meade location. The site is now the home of the Foreign Service Institute where people from across the foreign affairs community are trained in language, information technology, management, economics, area studies, and tradecraft.



### *James Madison University Visit David Kruger Summer Scottish Rite Clinic*

On **Wednesday, July 17**, the Valley of Alexandria will be visiting the Childhood Language Disorders Clinic at James Madison University. Receiving steady support from Alexandria Scottish Rite and the Scottish Rite Foundation of Virginia, the clinic operates the David Kruger Summer Scottish Rite Speech & Language Programs, which enable children with speech challenges, including autism, to improve their communication skills. ## *Significant Activity in Virginia Scottish Rite New Shenandoah Valley*

On May 16, 2024, thirty-nine Scottish Rite Brothers gathered at the Masonic Temple at Edinburg, VA for dinner and a special celebratory event. In late 2023, the Brothers residing in the Shenandoah Valley region around I81 and Rt 29 submitted a Petition for a Lodge of Perfection to our SGIG in Virginia, and having been signed by the requisite number of Brothers and meeting all necessary requirements of the Statutes of our Supreme Council of the 33°, their Petition was approved for submission to our Supreme Council.

Upon completion of all administrative details and being granted approval by the Sovereign Grand Commander, Letters Temporary dated effective May 1, 2024 and signed by our Sovereign Grand Inspector General were delivered to the Brethren assembled that evening, authorizing the temporary authority, in accordance with the Statutes, “to fix and collect fees to be paid by candidates and members... and to elect candidates for the purpose of conferring the Degrees upon them, to elect by affiliation members who have received such Degrees in other bodies and to do any and all things necessary and proper for the conduct of the business of such Body under the direction of the SGIG.” The Letters Temporary will be in force until the Form of Application for Charter of New Bodies is made to the Supreme Council, and is approved at the next regular session of the Supreme Council held in 2025, at which time a Charter may be issued.

The Brothers identified to lead “the Body so created temporarily” were instructed in their duties by MW and Ill. Alan W. Adkins, 33°, G.C., SGIG, assisted by MW. and Ill. Clifford A. (Skip) Parker, 33°. The provisional Venerable Master, Bro. John D. Petrie, II, 32°, was presented the Letters Temporary by SGIG Adkins. In addition to the Brothers of the temporary Body, and in addition to Illustrious Brothers Adkins and Parker, were visitors from Alexandria and Lynchburg Valleys who had come to support and witness this historically significant event.

Congratulations to our Shenandoah Valley Brothers and we will join you in looking forward to celebrating with you the receipt of your Charter.

## *Evolution & Growth of Orient of Virginia*

You've read about the new Letters Temporary for the Shenandoah Valley - a little background.

The 1761 authorization of Etienne (Stephen) Morin, "to establish perfect and sublime Masonry in all parts of the world" resulted in the 1762 establishment of Morin's 25 degree Order of the Royal Secret. The Grand Constitutions of 1786, updated portions of the original 1762 Constitutions increasing the number of degrees from 25 to 33 and establishing our Supreme Council organization, with provisions for both the Southern Jurisdiction ("The Mother Supreme Council of the World") and a second Supreme Council that would subsequently preside over the Northern Masonic Jurisdiction. The Supreme Council of the 33° formally declared its existence on May 31, 1801 in Charleston, SC.

Twenty three years later, on November 16, 1824, the Supreme Council chartered The Grand Consistory of Virginia in Lynchburg, the first Virginia Scottish Rite Body, and one that was composed of Brothers who had received the degrees of Moran's earlier Order of the Royal Secret. In 1869 a Lodge of Perfection was established in Lynchburg, followed by bodies in Norfolk in 1874, Richmond in 1878, Alexandria in 1911, Newport News in 1912, Roanoke in 1919, Danville in 1923, and Portsmouth in 1955. When the Shenandoah Valley is chartered in 2025, it will be the ninth Virginia Valley and the first new Valley chartered in Virginia in 70 years.

About that original Grand Consistory of Virginia in Lynchburg.

In The Lodge of the Double-Headed Eagle, William L. Fox describes the changes to the original organization of the Supreme Council in 1859 by SGC Pike. While the original Supreme Council had only 9 active members, the revised structure had the 33 members we have today, and the revised Statutes included provisions for one Grand Commandery in DC and each of the (at that time) 17 states of the Southern Jurisdiction. The 33 members were distributed across those states, with one member assigned to each of 7 states (MD, DC, NC, TX, IA, MN and CA) and 11 states with multiple active members (5 in SC, and 3 in LA; and 2 each in VA, GA, FL, AL, MS, TN, KY, AR and MO;).

Following Pike's 1881 death, the Grand Consistory of CA requested, in 1897, that it "give up its charter with the proviso that it be rechartered as a particular consistory, San Francisco No. 1." The Supreme Council's decision to approve the request was "the Consistory had proven to be impractical as an administrative unit." Fox goes on to say "Perhaps the elimination of the Grand Consistory in California reflected a growing belief that a Sovereign Grand Inspector General ought to be 'an active working administrator in his Orient and not confined to actions in the Sessions of the Supreme Council.' Ultimately, the Supreme Council would discard altogether the Grand Consistory as an administrative entity."

Fox quotes from a 1944 letter written by Grand Commander Cowles the following: "the original form of organization of the Scottish Rite was to have one Grand Consistory in each state or Orient or sub-jurisdiction... Then these Grand Consistories would issue the charters of the Lodges of Perfection, 4° - 14°; for the Councils of Princes of Jerusalem, 15° - 16°; for the Chapters of Rose Croix, 17° - 18°; for the Councils of Kadosh, 19° - 30°, but the Grand Consistories retained the 31° and the 32°. The subordinated bodies would be scattered over the state, but the members would have to come to the Grand Consistories to get the 31° and the 32°."

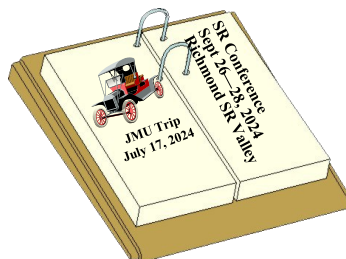
